**Section 4 - First Aid Measures**

**Eye contact:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing. Call a poison control center or doctor for treatment advice.

**Skin contact:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

Avoid contact with skin, eyes and clothing. Avoid breathing vapor or mist. Use only with adequate ventilation. Store and use away from heat, sparks, open flame or any other ignition source. Use explosion-proof electrical equipment. Use only non-sparking tools. Empty containers retain product residue and can be hazardous.

**Storage:** Store in a cool, dry area away from open flame. Do not store above 50°C (122°F).
