

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

If inhaled	Take off contaminated clothing Rinse skin immediately with plenty of water for 15-20 minutes

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Do not use on horses intended for slaughter.

WIPE N° SPRAY" has been especially developed for use on horses, it provides a protective hair coating against flies while imparting a high sheen to the hair when brushed out. 1 to 2 ounces per head per day gives adequate protection. Apoly by either soft cloth or fine soray mist.

USE TO WIPE ON:

First, brush animal to remove dirt and dust. Moisten (but do not wet to the point of dripping) a soft cloth and rub over the hair. It is best to apply by rubbing, against hair growth. Give special attention to legs, shoulders, shanks, neck and facial areas where files are most often seen. Only a light application is needed. Avoid using an excess amount. Do not wet skin. After application, brush out thoroughly to bring out bright sheen on the coat. Repeat daily or as needed.

USE AS A SPRAY:

WIPE N° SPRAY™ may be applied as a fine spray mist to horses and over and around stable area or stabled horses for fast paralysis and kill of files. Do not wet horse's skin or exceed two ounces per application.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. Storage: Store in a cool, dry place. Do not store near heat or open flame.
