Inhalation

Acute : Exposure to dust may cause nasal and respiratory irritation, Acute Silicosis can occur with exposures to very high concentrations of respirable crystalline silica over a very short time period, sometimes as short as a few months. Chronic : Excessive inhalation of crystalline silica (quartz) may cause lung injury.
