USE TO WIPE ON:

First, brush animal to remove dirt and dust. Moisten (but do not wet to the point of dripping) a soft cioth and rub over the hair. It is best to apply by rubbing against hair growth. Give special attention to legs, shoulders, shanks, neck and facial areas where flies are most often seen. Only a light application is needed. Avoid using an excess amount. Do not wet skin. After application, brush out thoroughly to bring out bright sheen on the coat. Repeat daily or as needed.
